Internal Notation – Complaints that the Charlottesville Police Department initiate through a review or information received that would arise to a violation of Department General Orders.

*Per General Order 517.01 – Internal Investigations and Citizen Complaints:

The Internal Affairs Investigator shall promptly draft a letter to the complainant, with a copy of the investigating supervisor's justification for the finding and notifying them of the completion of the investigation. The complainant will also be notified of their opportunity to speak with the investigating supervisor, Internal Affairs Investigator, or the Chief of Police regarding the finding.

Internal investigations may result in one or more of the following findings:

SUSTAINED – allegations true, and the officer is determined to have acted in violation of applicable procedures, techniques, and regulations.

NOT RESOLVED – Unable to verify the truth or falsity of complainant's allegations.

EXONERATED – Allegations true, but not misconduct due to adherence to applicable procedures, techniques, and regulations.

UNFOUNDED – No basis of fact to support the allegation.

Service-Related Inquiries are defined by Charlottesville Police Department policy as: "A matter of concern brought forth to the department, which does not rise to a violation(s) of departmental policy and/or a violation of the law."
